

1 AMENDMENT TO FY 2011 CONTRACT FOR ECONOMIC DEVELOPMENT
2 SERVICES WITHIN THE DOWNTOWN DURHAM DISTRICT BETWEEN THE
3 CITY OF DURHAM AND DOWNTOWN DURHAM, INC.

5 This contract amendment (“Amendment”) is made and entered into as of the ____ day
6 of _____, 20____, by the City of Durham (“City”) and Downtown
7 Durham, Inc. (“Contractor”), a 501(c) 6 not-for-profit corporation organized and existing
8 under the laws of North Carolina.

11 The City and the Contractor entered into a contract titled “FY 2011 Contract for
12 Economic Development Services within the Downtown Durham District Between the
13 City of Durham and Downtown Durham, Inc.” That contract is referred to as the
14 “Original Contract.” The Original Contract is hereby amended as follows:

16 1. At the end of Section Sec. 4. “Contractor Billings to City. Compensation” at the
17 following paragraph:
18

19 The City shall to pay the Contractor an additional \$35,000.00 for the last
20 quarter for additional program services administered by Contractor relating to the
21 City signage grant program. The addition funds under this Amendment will result
22 in a revised total funding amount not to exceed \$35,000.00 to the total contract
23 amount.

25 2. Attachment 1 Scope of Work Section g is hereby amended to read “DDI in
26 conjunction with OEWD will work to implement two major strategies from Downtown
27 Master Plan, including the administration of a signage grant program for downtown
28 businesses in accordance with guidelines agreed upon by OEWD and DDI”
