

**RESOLUTION TO RESCIND ELEVEN
PREVIOUSLY ORDERED PETITIONED SIDEWALK PROJECTS**

WHEREAS, the City Council on December 1, 2014, adopted a resolution setting a public hearing to consider rescinding eleven previously ordered petitioned sidewalk projects, in which said resolution January 5, 2015 at 7:00 P.M., was fixed as the time and the Council Chamber of City Hall as the place when and where a public hearing would be held on the proposed rescission of said sidewalks; and

WHEREAS, a notice of the public hearing was published in the Durham Herald Sun on December 22, 2014, , said date of publication being not less than ten days prior to the date that the public hearing was set; the notice stated that all objection to the legality of the rescinding of the ordering of said improvements are required by law to be made in writing, signed in person or by attorney and filed with the City Clerk at or before the time of said public hearing and that any such objections not so made will be waived; and

WHEREAS, a notice that a public hearing would be held on and at this specified time and place, generally describing the nature and location of the improvements to be considered for rescission has been mailed to the owners of all property subject to assessment if the projects herein described should be undertaken, said notices were mailed by first-class mail to said owners on December 19, 2014; and

WHEREAS, said public hearing has now been held and no objections have been made to the rescission of the previously ordered improvements / objections have been made to the rescission of the previously ordered improvements, which objections appear in the minutes of the City Council meeting;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DURHAM:

SECTION 1: That each final resolution ordering the making of local improvements, specifically sidewalk at the locations listed below, is hereby rescinded. These sidewalk projects are:

1. South Roxboro Street (East Side) from Juliette Drive south to Greyfield Boulevard
2. Juliette Drive (North Side) from South Roxboro Street to PIN #0729-01-16-2672
3. Infinity Road (South Side) from Shadebush Drive to Lazyriver Drive
4. Green Street (South Side) from Gregson Street to Watts Street
5. Monmouth Avenue (South Side) from North Buchanan Boulevard to Watts Street
6. Fayetteville Road (West Side) from the north property line of PIN 0717-02-69-7405 to the south property line of PIN 0717-02-69-7405
7. Sedwick Road (North Side) from Revere Road to Grandale Drive
8. University Drive (East Side) from Durham Chapel Hill Boulevard to West Forest Hills Drive
9. Hardwick Drive (North Side) from the west property line of PIN 0728-03-24-3003 to Wellingham Drive

10. Yorktown Ave (West Side) from Martin Luther King, Jr Parkway northeast to the northeast property line of PIN 0739-01-05-9585
11. Grandale Drive (East Side) from Sedwick Road to Lyon Farm Drive

SECTION 2: That any resolutions or policies in conflict with the provisions of this resolution are to the extent of such conflict repealed.

SECTION 3: This resolution shall be effective upon the date of passage.
