- City Council Work Session- **Council expects a representative from the winning contractor to answer questions about the workforce statistics and hiring practices.**
- Project Details:
 - 500 days to finish work
 - services contract for ombudsman services, traffic and pedestrian control plans, curb ramp designs and inspection services. – **SW-76C**
 - PDRx
 - 10 days from NTP to begin work.
 - 15 day notice to residents prior to work.
 - Curb ramps for repaving projects.- **has to comply with PROWAG**
 - Line Items:
 - 6” of ABC Stone (or #57) is included in concrete line items. The Incidental items are for any additional necessary
 - Asphalt line items are for paving in gutters or areas where filling in asphalt is necessary to sidewalk work. No binder adjustments will be included.
 - Sawcutting is incidental to removal.
 - Traffic Control item includes variable message boards as required
 - Tree protection Sidewalk **includes #57 stone**
 - Work in NCDOT Right of Way
 - All locations in Downtown Durham will conform to Downtown Durham Standards with a 2-brick soldier course on the back of curb and a brick field at curb ramps.
 - At curb ramps where the current curb and gutter needs to be replaced, the new curb and gutter will be installed at the proper elevation. Sometimes this will mean the gutter needs to be paved in with asphalt to make everything compliant.
 - PROWAG
 - Locations – **Due to funding and priority changes on going, project locations are not finalized yet. So a complete locations list might not be provided. Quantities in Unit price bid table represents the work to be done. No changes in the type of work and changes in line items not anticipated now.**
