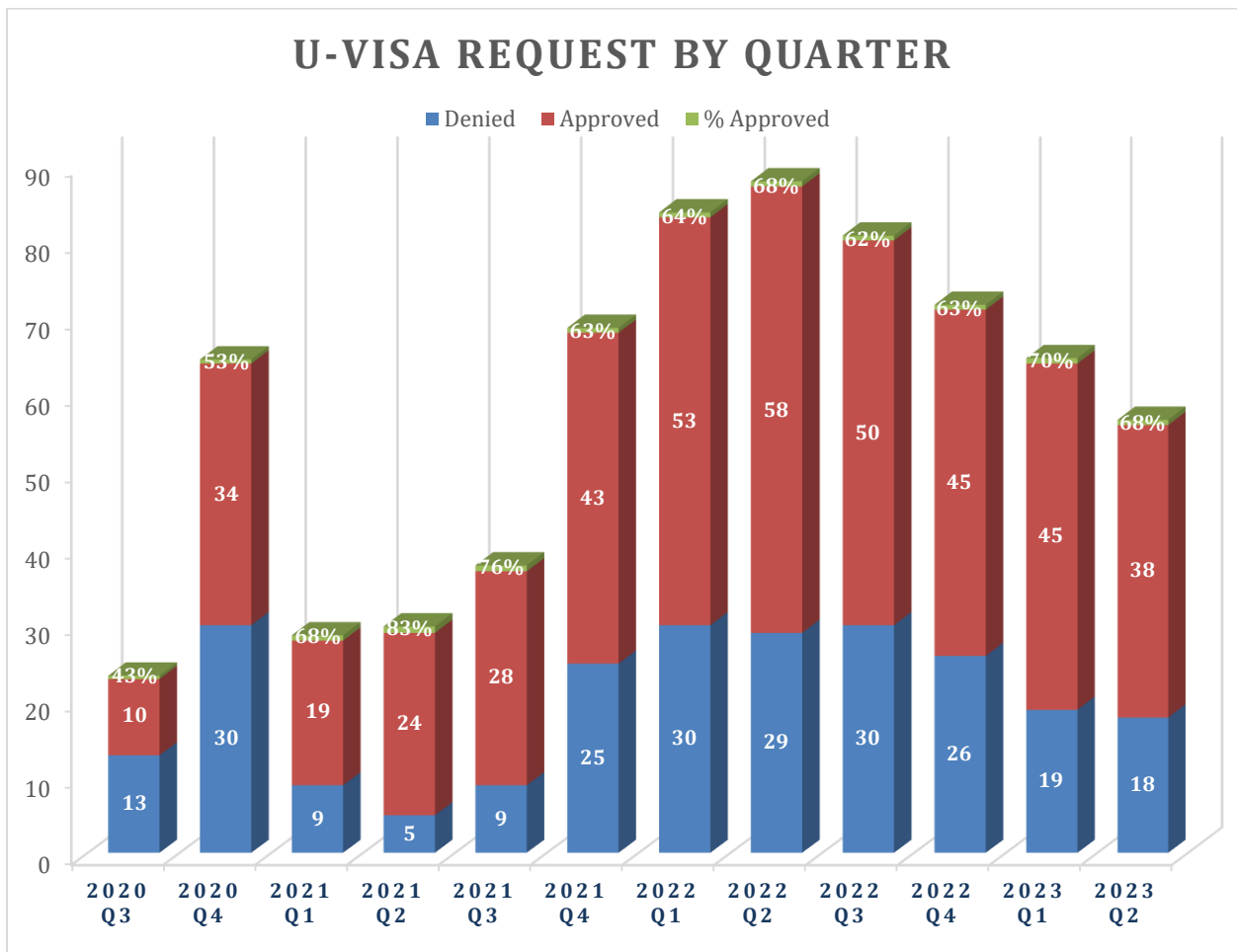

Subject: 2023 2nd Quarter U-Visa Certification Report

During the months of April through June 2023, the Durham Police Department received fifty-six (56) requests for law enforcement certifications of U-Visa Nonimmigrant Status applications. Thirty-eight (38) certifications were provided and eighteen (18) were denied. A spreadsheet of the requests is below along with a quarterly comparison chart. Sixty-eight (68) percent of the requests submitted this quarter were certified.
